Re: FY25 appropriations request for a national PrEP program at CDC

Dear Chairs Baldwin and Aderholt and Ranking Members Capito and DeLauro,

On behalf of a wide coalition of HIV and health organizations and advocates, the 179 organizations below respectfully urge you to include \$100 million in discretionary funding to continue development of a National PrEP Program as part of a \$175 million increase for CDC's Ending the HIV Epidemic initiative in the Division of HIV Prevention. Additionally, we urge you to include report language that would help ensure integration and implementation of a PrEP program that is national in scope, as is permitted under CDC's current authorization.

Expanding Access to and Uptake of PrEP Is Needed to End the HIV Epidemic

The bipartisan Ending the HIV Epidemic initiative calls for 50% of the approximately 1.2 million people who could benefit from PrEP in the U.S. to have access by 2030. We can and should exceed this goal. Currently, only 36% of individuals in need of PrEP are using it, with significant disparities based on race, ethnicity, geography, age, and other factors. Despite making up 42% of new HIV diagnoses in 2021, Black individuals accounted for only 14% of PrEP users in 2022. Similarly, Hispanic individuals accounted for 27% of new HIV diagnoses in 2021 yet made up only 17% of PrEP users in 2022. These disparities jeopardize our progress toward ending HIV as an epidemic; in a recent analysis out of Emory University, states with the highest PrEP coverage showed an annual percentage decrease in HIV diagnoses of 8% (2012 - 2021) while states with low PrEP coverage increased 2% each year.²

A National PrEP Program Is Needed to Reduce Costs Associated with New HIV Infections

In the U.S., low access and uptake of PrEP prevents the nation from realizing its full benefit, including the prevention of thousands of new HIV acquisitions each year as well as the substantial lifetime costs

associated with each new case. A 2022 article published in the Journal of Law Medicine and Ethics estimated that every 1,000 monthly PrEP prescriptions would cost \$80,000.³ *Six thousand monthly prescriptions would cost less than \$500,000, the lifetime value of just 1 prevented HIV infection.* A strong national PrEP program would help to improve health and reduce costs by increasing ready access to affordable PrEP medication and required medical services.

In addition to funding this request, and maintaining funding for other domestic HIV programs that support PrEP activities, we urge you to please include the following report language for a National PrEP Program that would cover current gaps in services and reach all people who are at risk for HIV:

Domestic HIV/AIDS Prevention and Research. Ending the HIV Epidemic and Access to PrEP.— The Committee includes a \$175 million increase for CDC's Ending the HIV Epidemic program, with at least \$100 million of that funding to support increasing equitable access nationwide by race, ethnicity, income, geography or other appropriate measures to pre-exposure prophylaxis (PrEP), medication that prevents HIV. Funding should support a national program to increase awareness of PrEP; access to PrEP medications, necessary laboratory services, and essential support services, such as case management, counseling, linkage, and adherence services; robust PrEP outreach and education activities; and PrEP provider capacity expansion. CDC shall submit a report to the Committee within 180 days of enactment of final FY25 appropriations on the status of a national PrEP initiative.

A National PrEP Program would help to end the domestic HIV epidemic by reducing thousands of new cases per year, improving health outcomes, and reducing health care costs. Thank you so much for your time, consideration, and leadership on this critical issue impacting families and communities nationwide.
